



Terms and Conditions of Trans-Island Chinalink x Guangzhou BONGSKI Package Promotion for Standard Chartered A. Point Card Promotion (the “Promotion”)

1. Unless otherwise specified, the promotion period is valid from 20 March 2025 to 28 February 2026 (both dates inclusive) (the “**Promotion Period**”).
2. Unless otherwise specified, to be eligible for the Promotion, cardholders (“**Cardholders**”) are required to make Eligible Transactions with Standard Chartered A. Point Card issued by Standard Chartered Bank (Hong Kong) Limited (the “**Bank**”) (the “**Eligible Card**”).
3. Point card account within 20 working days after the Eligible Transaction has been posted; and will not be applied automatically on the transaction page.

4. (d) For Offline purchase at Eligible Centres, Eligible Centers refer to the Trans-Island Chinalink ticketing centers in Hong Kong (excluding the ticketing centers in Mainland China and Macau). Cardholders shall visit the Merchant website (https://www.tilchinalink.com/ticketing_centers.php) for the latest list of Eligible Centers in Hong Kong. To enjoy the instant HKD50 discount offer, Cardholders shall make the payment with the Eligible Card at Eligible Centres. The Promotion shall be terminated immediately upon closure of the Eligible Centers, the Merchants or any of their respective outlets.
